

Giveaway and Sweepstakes Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Eligibility

Cotiviti, Inc. ("Cotiviti") T-shirt Giveaway (the "Giveaway") and Allbirds® Gift Card Sweepstakes (the "Sweepstakes") is open only to individual females aged eighteen (18) years or older who are registered participants or attendees of RISE National 2026 (the "Conference"). Employees of Cotiviti, Conference vendors, and other companies associated with the promotion of the Giveaway and Sweepstakes, and their respective parent companies, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. Only one (1) entry per person during the entire Sweepstakes Period. Additional entries submitted by the same person will be void and may result in disqualification of the entrant, at Sponsor's discretion. The Giveaway and Sweepstakes is subject to federal, state, and local laws and regulations, and is limited to participants who reside in the United States or Canada. Void where prohibited.

2. Sponsor

3. Agreement to Official Rules

Participation in the Giveaway and Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsors, which are final and binding. Winning a prize is contingent upon the participant being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Giveaway and Sweepstakes Period

The Giveaway and Sweepstakes period begins on Monday, 3/23, 4:30 pm EST and ends on Wednesday, 3/25, 10:50 am EST (the "Giveaway and Sweepstakes Period"). Entries that are submitted before or after the Giveaway and Sweepstakes Period will be disqualified. Submissions will be accepted for the duration of the Giveaway and Sweepstakes Period using the entry method set forth in Section 5, below.

5. How to Enter

To enter the Giveaway, eligible participants must: Visit the Cotiviti booth during the Giveaway Period. A Cotiviti-branded t-shirt will be provided to any women that visit the booth and have their badge scanned by booth staff. Entrants will only be eligible for one (1) prize under this Giveaway.

To enter the Sweepstakes, participants must scan the QR code provided at the booth and submit their contact information (name, company, and work email address). After submitting, they will be entered to win an Allbirds® \$100 gift card, valued at \$100 USD. Three winners will be randomly selected by Cotiviti using a random number generator upon the conclusion of the Conference. Entrants will only be eligible for one (1) prize under this Sweepstakes. Winners need not be present to win.

6. Winner Notification

The Sweepstakes winner will be notified by email from Cotiviti within five (5) business days of the event's conclusion. Winners must continue to comply with all terms and conditions of these Official Rules. If a prize winner does not redeem the prize within the timeframe specified in the notification email, the prize will be forfeited.

If applicable: Once redeemed, the Sweepstakes prize will be provided either digitally or by direct mail to the address provided by the winner(s) within a reasonable timeframe, no more than two weeks. If the Sweepstakes prize is being sent digitally, it will be sent to the email address provided by the winner(s).

If the prize is unavailable for any reason, Sponsor reserves the right in its sole discretion to substitute the prize with one of comparable or greater retail value.

8. General Conditions

All entries and information submitted shall become the exclusive property of the Sponsor. All federal, state, and local taxes, and any other costs or expenses not specifically identified in these Official Rules, are the sole responsibility of each winner. By accepting a prize, winners grant permission to Sponsor to use their name and/or likeness for promotional purposes without further compensation, unless prohibited by law. Sponsor reserves the right to amend these rules or terminate the Giveaway and Sweepstakes at any time. In the event that the operation, security, or administration of the Giveaway or Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Giveaway or Sweepstakes is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Giveaway or Sweepstakes to address the impairment and then resume the Giveaway or Sweepstakes in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Giveaway or Sweepstakes and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Giveaway or Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Giveaway or Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

10. Release and Limitations of Liability

By participating in the Giveaway or Sweepstakes, entrants agree to release and hold harmless the Sponsor, and its parent, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Giveaway or Sweepstakes, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Giveaway or Sweepstakes or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Giveaway or Sweepstakes, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Giveaway or Sweepstakes; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads, (e) any other errors or problems in connection with the Giveaway or Sweepstakes, including, without limitation, errors that may occur in the administration of the Giveaway or Sweepstakes, the announcement of the winner, shipment and/or delivery of the prize, the cancellation or postponement of the event, the incorrect downloading of the application, the processing of entries application downloads or in any Giveaway or Sweepstakes -related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Giveaway or Sweepstakes or acceptance, receipt, use or misuse of the prize (including any travel or activity related thereto). Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Giveaway or Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Delaware, and matters related to the Giveaway or Sweepstakes, shall be governed by, and construed in accordance with, the laws of Delaware, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Delaware. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. If any provision of these Official Rules is invalid or unenforceable, such provision shall be struck, and the remaining provisions shall be enforced.

12. Privacy

Information collected from entrants is subject to sponsor's privacy policy. By scanning the QR code and submitting their contact information (name, company, and work email address), you agree that the Sponsor and its representatives may contact you using any email address, telephone number, or postal address you provide. Any personally identifiable information collected during a participant's participation in the Giveaway and Sweepstakes may be used and

shared by the Sponsor (i) for the administration and fulfillment of the Giveaway and Sweepstakes, (ii) to contact you (including by auto dialed and other phone calls and text messages, e-mail messages, and/or postal mail) for any purpose in accordance with this Giveaway and Sweepstakes; and/or (iii) as otherwise disclosed at the point of collection or with the participant's consent.
